ABOUT THE BRAND PERFORMANCE CHECK

Fair Wear Foundation believes that improving conditions for apparel product location workers requires change at many levels. Traditional efforts to improve conditions focus primarily on the product location. FWF, however, believes that the management decisions of clothing brands have an enormous influence for good or ill on product location conditions.

FWF's Brand Performance Check is a tool to evaluate and report on the activities of FWF's member companies. The Checks examine how member company management systems support FWF's Code of Labour Practices. They evaluate the parts of member company supply chains where clothing is assembled. This is the most labour intensive part of garment supply chains, and where brands can have the most influence over working conditions.

In most apparel supply chains, clothing brands do not own product locations, and most product locations work for many different brands. This means that in most cases FWF member companies have influence, but not direct control, over working conditions. As a result, the Brand Performance Checks focus primarily on verifying the efforts of member companies. Outcomes at the product location level are assessed via audits and complaint reports, however the complexity of the supply chains means that even the best efforts of FWF member companies cannot guarantee results.

Even if outcomes at the product location level cannot be guaranteed, the importance of good management practices by member companies cannot be understated. Even one concerned customer at a product location can have significant positive impacts on a range of issues like health and safety conditions or freedom of association. And if one customer at a product location can demonstrate that improvements are possible, other customers no longer have an excuse not to act. The development and sharing of these types of best practices has long been a core part of FWF's work.

The Brand Performance Check system is designed to accommodate the range of structures and strengths that different companies have, and reflects the different ways that brands can support better working conditions.

This report is based on interviews with member company employees who play important roles in the management of supply chains, and a variety of documentation sources, financial records, supplier data. The findings from the Brand Performance Check are summarized and published at www.fairwear.org. The online [Brand Performance Check Guide](#) provides more information about the indicators.

Summary:

In 2017, DW Shop has met most of FWF's performance requirements. It monitored 85% of its purchasing volume, meeting the required monitoring threshold. This, combined with a score of 57 places DW Shop in the Good category.

A significant part of DW Shop's production comes from homemaker suppliers. DW Shop has followed the monitoring policy regarding homeworkers adopted by FWF. DW Shop enrolled more suppliers for WEP trainings which is a positive thing to raise workers awareness about their rights and the FWF helpline.

DW Shop has had long-term relationships with many suppliers, or has purchased over 10% of a supplier's production for over half of its suppliers, but the company still has many small suppliers where it buys small quantities. FWF advises the company to work on consolidating its suppliers base and conduct better due diligence before starting to work with new factories.

Most audits conducted in the past financial years have shown severe non-compliance with FWF's labour standards, and DW Shop's progress towards resolving existing Corrective Action Plans is insufficient and requires improvement. The company needs to emphasise work towards payment of a living wage and improve follow-up on remediation of payment of the legal minimum wage. Besides, a root cause analysis of excessive overtime should be done to investigate which steps can be most effective to reduce it. Special attention should be given to piloting advanced work with those factories from which DW Shop buys a large percentage of its production volume.

PERFORMANCE CATEGORY OVERVIEW

Leader: This category is for member companies who are doing exceptionally well, and are operating at an advanced level. Leaders show best practices in complex areas such as living wages and freedom of association.

Good: It is FWF's belief that member companies who are making a serious effort to implement the Code of Labour Practices—the vast majority of FWF member companies—are 'doing good' and deserve to be recognized as such. They are also doing more than the average clothing company, and have allowed their internal processes to be examined and publicly reported on by an independent NGO. The majority of member companies will receive a 'Good' rating.

Needs Improvement: Member companies are most likely to find themselves in this category when major unexpected problems have arisen, or if they are unable or unwilling to seriously work towards CoLP implementation. Member companies may be in this category for one year only after which they should either move up to Good, or will be moved to suspended.

Suspended: Member companies who either fail to meet one of the Basic Requirements, have had major internal changes which means membership must be put on hold for a maximum of one year, or have been in Needs Improvement for more than one year. Member companies may remain in this category for one year maximum, after which termination proceedings will come into force.

Categories are calculated based on a combination of benchmarking score and the percentage of own production under monitoring. The specific requirements for each category are outlined in the Brand Performance Check Guide.

Comment: 51 % of DW Shop production volume comes from production locations where it buys at least 10% of production capacity which is just a bit over last year's percentage.

DW Shop has 26% of its FOB produced at 5 suppliers in India and Indonesia where it has between 60% and 100% leverage. At the same time DW Shop has many small suppliers of which it buys small quantities, in countries and areas with high risks on social standards.

Recommendation: FWF recommends DW Shop to consolidate its supplier base where possible. It is advised to describe the process of consolidation in a sourcing strategy that is agreed upon with top management/sourcing staff.

Comment: 27% of DW Shop production volume comes from production locations where it buys less than 2% of its total FOB, which is a significant percentage of its orders.

Recommendation: FWF recommends DW Shop to consolidate its supply base by limiting the number of supplier in its 'tail end'. To achieve this, members should determine whether suppliers where they buy less than 2% of their FOB are of strategic relevance. Shortening the tail will reduce the social compliance risks the member is exposed to and will allow the member to improve working conditions in a more efficient and effective way.

It is advised to describe the process of consolidation in a sourcing strategy that is agreed upon with top management/sourcing staff.

Comment: DW Shop has long-term relationships with about two third of its suppliers (almost 10 years). However, the percentage of production volume from production locations where the brand a business relationship has existed for at least five years has decreased a bit compared to the previous financial year due to the variety of products ordered in a bigger number of factories.

Recommendation: FWF recommends DWS to maintain stable business relationships with suppliers. Long term relationships support most aspects of the Code of Labour Practices, and give factories a reason to invest in improving working conditions.

It is advised to describe policies regarding maintaining long term business relationship in a sourcing strategy that is agreed upon with top management/sourcing staff

Comment: DW Shop started new relationship with 10 new production locations in 2016 and could show that all questionnaires with Code of Labour Practices had been signed and filled in.

Comment: Chief buyers, in co-operation with the managing director, select new factories. Main criteria for choosing a new supplier are the range of products and its quality. DW Shop buyers discuss social compliance issues during the introduction, and visit actual production locations before starting working with a new supplier. In case of cooperation with agents, agents visit the production sites before first orders are placed. DW Shop is aware of country specific risks through FWF country studies, but the due diligence process doesn't address those well.

Requirement: A formal process should exist to evaluate the risks of labour violations in the production areas where DW Shop operates. This evaluation should influence the decision on whether to place orders, how to prevent and mitigate risks, and weigh the possibilities it sees to contribute to mitigate and remediate the risks.

Comment: DW Shop evaluates supplier compliance to a certain level. DW Shop keeps an excel file per supplier and a suppliers overview with their scoring.

A supplier evaluation sheet has been developed in the last financial year but remains under development. Different parameters related to buyers requirements (quality, time frame, price), CSR and CAP follow up are used and graded 1 to 6. This is shared with suppliers so they fill in info and know their score but has had no decision impact yet. When communication is really too difficult and a factory is not cooperative the relationship might come to an end.

DW Shop finds it difficult to reward good factories with quantities because of the wide products' range. Another limit to this is that some factories are very small and don't have enough capacities to take on more orders.

DW Shop stopped working with a factory in 2015 and started relationship again in 2016, which is not a responsible way to work with a supplier, especially when the company was responsible for almost all orders at that production location. DW Shop is currently trying to find an investor for this production location in order for it to achieve financial sustainability and continue working with it, as it is a very old supplier. Relationships were ended in the second half of 2016, with the UK supplier and an Indian factory, the latest because of prices raise issue.

Recommendation: A sourcing strategy including due diligence process and exit strategy should be developed by DW Shop. This could also go hand in hand with the newly developed Supplier Evaluation tool. As it is not always possible to reward suppliers with more volumes, DW Shop could look into other incentives that reward supplier's commitment towards the CoLP. An example would be to offer buyer paid training for skill building/capacity development.

Comment: DW Shop produces three collections every year with a 65/35 summer/winter ratio. Production planning on the supplier side is usually six to eight months (including 8 to 10 weeks for orders placement, 2 to 3 months for production, buffer and delivery). Production planning is done together with an agency for India - with weekly basis milestones production follow up. The cutting stage should start 3 or 4 weeks before shipping time. At several production sites, DWS has a small leverage. Upon request, factory management of those locations responded that it is other brands causing excessive overtime hours. DW Shop states that they often have to accept their production being delayed as their order volume is small sometimes even shifting an item to the next season's collection. Besides, DW Shop also splits deliveries and pays air freight if needed for re-orders, which can help to reduce the risk of excessive overtime.

Recommendation: It is advised to establish a system for sharing and updating forecasts with suppliers to facilitate their planning. The system may include assurance of early delivery of materials and trimmings to suppliers, ensuring samples are approved in time and that late changes are discussed with the supplier. A good production planning system needs to be established based on the production capacity of the factory for regular working hours.

Comment: Overtime issues (overtime, registration or payment of overtime) were found in most of the factories audited by FWF in the last 3 years and there is very little proof of improvement - even though DW-Shop accepts late shipments and split deliveries.

To get information on factories' capacities, DW Shop looks at the number of available machines and their agents also check (is it the appropriate machine?) when visiting. Factories capacities are also updated thanks to a Company info sheet shared with suppliers and collected by the brand. DW Shop shares labour minute methodology with factories to try to implement it but without any success yet, and it didn't conduct research on root causes of overtime.

There is no clear visibility on planning process even at suppliers where DW Shop buys over 50% of the factory's capacity.

Requirement: A root cause analysis of excessive overtime should be done to investigate which steps can be most effective to reduce overtime. Special attention should be given to piloting advanced work with those factories from which DW-Shop buys a large percentage of the production volume.

Recommendation: The outcomes of the root cause analysis can be used for identifying strategies that minimise the impact of its sourcing practice on working hours at other factories.

DW Shop could support its suppliers more on production planning.

Comment: DW Shop includes experience with the supplier, previous prices and market development in its price. Labour costs are discussed but suppliers are not open to share those as they do not necessarily understand why it is needed. DW-Shop claims to pay a higher price than other companies but higher wages resulting from this could not be verified in audits.

Quotations are collected from suppliers and if the prices are too high then the garment quality or design is changed to achieve a lower price. However, DW Shop doesn't refuse a quotation because of prices, if not satisfied they will go to another factory or cancel the order. Margins fluctuate and can be lowered if needed to achieve target retail price, as the company's turnover grew importantly in the last years.

The CSR staff looks at wages documents when visiting factories and is aware that the security guards are often paid below minimum wage. She also started to work on costing sheet per style, without any implementation for now.

Buyers are aware of minimum wages in different countries but DW Shop doesn't know if prices paid to its suppliers allow payments of minimum wages.

Recommendation: At a minimum, DW Shop is recommended to investigate wages levels in production countries, among others by making use of FWFs Wage Ladder and country studies. As an advanced step, increased transparency in costing and productivity gives insight in the labour costs per product. This forms the basis for ensuring enough is paid to cover at least minimum wage and for making steps towards living wages.

Comment: DW Shop informs the production sites about legal minimum wages that should be observed at the beginning of the cooperation. In case of problems found after audits, they communicate with factory management to ask them to resolve the issue. Payment below legal minimum wage was found in four out of eight audits in last financial year (often security guard and no verifiable system for wages payments). Documents to proof that minimum wages are paid have been shown to DW Shop by only one production site. Results have not been verified by FWF yet.

Requirement: If a supplier fails to pay minimum wages, DW Shop expected to hold management of the supplier accountable for respecting local labour law and require a time bound action plan to ensure adequate payment. Factory visits with a documents check or additional verification by FWF may be needed verify remediation.

Recommendation: It is strongly recommended not only to ask the supplier whether legal minimum wage has been paid after such findings, but to systematically collect proofs (such as pay slips)..

Comment: DW Shop CSR staff tracks local legal minimum wages increases and is aware of regional minimum wages. However, low leverage from the company at numerous production locations makes it difficult to discuss living wages.

Where the company has higher leverage the main priority is more on production planning than wages but DWS said they started to talk about the issues but believe other parameters such as lead time and production should be taken into account in this discussion.

At suppliers where DWS has 100% leverage in India, workers are paid more than regional minimum wage. With homeworkers - in Peru - CSR staff looked at payment slips, met and interviewed the workers who agreed that they received minimum wage. They are often paid by piece. Discussion about living wage directly with factory management is even more complicated when homeworkers are involved.

Recommendation: FWF encourages DWS to assess the hypothetical cost effects of increasing wages towards benchmarks that are included in the wage ladder. To support companies in this process FWF has developed a calculation model that estimates the effect on FOB and retail prices under different pricing models.

Comment: Regular communication takes place between DW Shop and its suppliers. DW Shop CSR manager visits regularly the suppliers to meet them in person to discuss CAPs. She organises CAPs according to urgency of findings then put these in bold and red and asks for feedback within timelines.

Recommendation: In case worker representation exists in factories CAPs should be shared with worker representative as well as involved in setting the timeframe for realising improvements.

Comment: DW Shop discusses CAPs with its suppliers and seeks remediation on urgent issues in priority. It is acknowledged that low leverage at some factories can make remediation difficult, but even where the company had a very long relationship, serious issues still exist and should be addressed. The buyers who travel to the audited suppliers get instruction from the CSR staff person what to check with suppliers in general. Several production sites have been visited and CAPs discussed. DW Shop also uses audit reports from other sources during the 2 years gap between FWF audits, in order to follow up on CAPs (and update those).

A majority of audits conducted in the past financial year have shown severe non-compliance's towards FWF's labour standards. DW Shop doesn't seem to have progressed or help factories progress on issues such as legal minimum wage payments, age verification and overtime. Indeed, the company could show communication with factories about the issues, but often documentation and proofs of improvements were missing. Poor documentation, fake documents is a common finding at Indian suppliers and seems not to have been remediated in the last years.

Requirement: Resolving and remediating non-compliances is one of the most important criteria FWF Member companies can do towards improving working conditions. FWF expects DW Shop to examine and support remediation of any problem that they encounter. Coordinated efforts between different departments are required to ensure sustained responses to CAPs.

Recommendation: To facilitate remediation, DW-Shop could consider:

- Hire a local consultant to assist factory in developing an action plan and to assist factory management in investigating root causes.
- Organise supplier seminars.
- Provide financial support to the supplier for implementing improvements.

FWF recommends DWS to use its high leverage at main supplier(s) to effectively request improvements of working conditions.

Comment: DW Shop doesn't source in Bangladesh or Myanmar. One jeans production location was visited by former buyer who could confirm sandblasting doesn't take place.

About India specific risks, DW Shop and its agent for Indian factories are aware of specific risks in different regions and in particular of Child Labour risks. The CSR staff met with the agency in April 2016 and shared the FWF requirements and COLP. (before that it had a local office). One person in the agency is in charge of social standards - this person went to a factory together with the CSR staff. CAP follow up in India is made together between the agent and the CSR person.

DW Shop shared FWF policy on Refugees in Turkey with its Turkish suppliers but deeper investigation should be made.

The company has a significant amount of suppliers working with homeworkers and uses FWF Homeworkers guidance document to monitor that part of their production. It could show questionnaires of homeworkers in Indonesia and Peru that were visited by the CSR manager.

Requirement: DW Shop is required to draft a policy against sandblasting and include this in their annual work plan for FWF. In the social reports DW Shop is required to publicly report on the implementation of the ban.

Recommendation: DW Shop can agree on additional commitments that are required to mitigate specific risks with its suppliers. The company can provide additional measures in its monitoring system.

Requirement:

In the tail end of DW Shop's supplier base, FWF requires to ensure DW Shop audits all production locations that are responsible for over 2% of production and production locations where it is responsible for over 10% of the location's production capacity. One Turkish supplier where DW Shop buys a bit over 2% of its FOB has still not be audited.

DW Shop could show that the company follows FWF's guidance on homeworkers production monitoring by visiting 20% of the homeworkers facilities. The factories working with homeworkers in South America and Indonesia have been visited but no audit report has been collected. For these reasons, in this brand performance check, it was decided that half of the FOB produced at 3 production locations using homeworkers (which represents 8%) would be counted in the total monitoring threshold. In order to be fully counted in for the coming years, FWF expects DW Shop to conduct audits or collect external audit reports for the main factories.

Comment: When visiting factories the CSR person insists she needs to know all subcontractors working with the supplier even if not used for DW Shop production. Then a second step is to know whether the subcontractor is used for the company's production. If so then the FWF questionnaire and COLP are shared with subcontractors.

The Indian agency helps checking subcontractors as they visit the factories. For example at Sneh design the agent didn't see DW Shop products made outside of the factory. In China also local technician checks production and thus can inform about subcontractors but distances are bigger so it is a bit more complicated.

DW Shop follows the FWF guidance on home-based work; collects information through questionnaires and visits head of homeworkers groups accompanied with a translator. It knows which tasks they do and which percentage of production it represents in relation to the main factory output.

Recommendation: FWF recommends DWS to periodically check with its agents whether all known production locations are still up to date and use the information coming from questionnaire to update supplier data, including subcontractors.
